On Monday, October 28th, I had the privilege of representing the Martin C. Kaufman One Hundred Club of Alameda County at the awards banquet following the 2013 Urban Shield exercises. Urban Shield, established by our Sheriff Gregory J. Ahern in 2007, is a two-day event in which first responders participated in a series of realistic scenarios designed to improve their ability to respond to critical events. This year, Urban Shield participants included S.W.A.T. teams from thirty-three agencies. Most were from California, but two agencies from Texas and one from Brazil also participated. In addition, seven Explosive Ordnance Disposal Units and twenty-six fire agencies, including a team from St. Paul Minnesota, took part in the exercises.

Alameda County Sheriff Greg Ahern and his staff deserve high praise for organizing Urban Shield. The organizers set up sixty realistic scenarios at locations throughout the Bay Area. Each scenario was designed to test the ability of the participating teams to respond to critical events. These events ranged from active shooter situations, to terrorist attacks, to hazard materials spills. The training they receive pays off. In a congressional hearing, officials from Boston credited their city's participation in Urban Shield for their ability to respond effectively during the Boston Marathon bombings.

The awards banquet honored all the agencies that took part in Urban Shield. The keynote speaker was General Wesley K. Clark (ret.), who delivered an inspirational speech that stressed the importance of teamwork and training in the first responder community. The presentation of awards for the S.W.A.T. competition was a highlight of the banquet. We should be proud that Alameda County agencies won the top two awards. The Alameda County Sheriff's Department S.W.A.T. team took second place, and the Berkeley Police Department S.W.A.T. team won top honors.

Each year, Sheriff Ahern designates a charity to receive the proceeds from donations and the raffle. This year, our Club was that charity. At the banquet, I was presented with a check to our Club for \$8,500. Thank you, Sheriff Ahern.

I look forward to seeing all of you at our Winter Dinner in Sunol on February 5.
