Sabrina Williams Speech - Winter Dinner 2014

We have received many requests for a copy of Sabrina's heartfelt speech from the Winter Dinner last year. She has graciously allowed us to print a copy for our members in this issue of the Informer.

I met Ken Mercer of The 100 Club at my tiny apartment the morning of January 10th, 1999. He came only hours after my husband's passing to introduce himself, share a few words about the club and to give me a check to help me with whatever I needed. He gave me a genuine, heartfelt hug, expressed his deepest condolences, and with tears in his eyes, handed me his card. His final words were to call on him at anytime for anything and just as swiftly as he had appeared, he was gone. Like a visitation from an angel, no fanfare, no photo op, no pretense, just real concern, real compassion and real assistance. I found out tonight that he passed two weeks ago. He was an exemplary individual and embodied all of the 100 Club values and was my introduction to the Martin C. Kaufmann 100 Club.

It's hard to believe that it's been 15 years since I walked into this room for the first time. My family & I had gotten lost on the way here and were late. I was mortified. To make matters worse, everyone was waiting till I arrived to begin. It had only been weeks since my husband Jimi had been taken from us, so to say that I was still shell shocked would be an understatement. As I walked into the room, I felt as if I were moving in slow motion. I saw a sea of concerned faces. I could feel their warmth, all searching for the right words to say to me if I happened to pass them or be introduced. Over & over I heard, I'm so sorry for your loss. No matter how many times I heard it, each condolence was as sincere as the last. Everyone I met was wonderful.

That night I met Tammy Monego who had lost her husband John less than a month prior. She made sure she reached me through the group surrounding me.

She used her CHP training to circumvent any obstacle to introduce herself and to make sure I had her number. Though she was dealing with her own grief & loss, she wanted me to know I could call her anytime to talk. That meeting led to one of the closest friendships I've ever had. She's been a friend, sister, & therapist. We have supported each other for 15 years, in good times and bad and our friendship only gets stronger with each passing year.

Over the years I've watched one television show and movie after another depicting law enforcement officers as brutal, lying, womanizing individuals and abusers of power. When one is lost in the line of duty you'll read line after line about the perpetrator. Their sad upbringing, how their family and the system failed them, how society is responsible for choices they themselves made. You're then left with a few lines about the officer who lost their life and about the family who are left to mourn them. Just once I'd like to see a movie or television show depicting an officer spending time with his family, changing diapers, reading bedtime stories, sharing birthdays, holidays, going to church, attending parent teacher night and tenderly kissing his wife and saying I love you for no reason other than to see her smile. Then to show that fateful day, not knowing it will be for the last time, he puts on his uniform, hugs & kisses his wife and family goodbye, never to return home, their lives changed forever by a sniper's bullet. That person was Officer James Williams, Jr., That was my life,

When you lose a spouse or loved one in the line of duty, you soon find out that it is unlike any other, especially if you must face the grueling years that follow participating in trial preparation and ultimately the trial.

Having to face the person or persons responsible for robbing you of your future is almost unbearable. This isn't an episode of Law & Order, this is your life and it happened to you. Somehow you dig deep within yourself, find the will you never knew you had and persevere. You do it for your children, your family & loved ones. Most of all you do it for the person you lost and loved so very much, to honor their memory and the life you shared.

It's true I've had my share of sadness & loss but I've also had many triumphs. Over the years I coached my sons basketball teams to championships, I coached my daughter's volleyball team and went undefeated, been team mom, room mother, Mrs. Claus, school board member, and driven on every field trip. I loved every single minute of it. I have been their champion and they have been mine. I have watched my children grow into loving, caring, intelligent individuals that their Father would be proud of.

They are not 10, 5 & 4 year old children but 25, 20 and 19 year old adults who make me proud everyday.

I am now married to a remarkable man, Darrell Robinson, who has never felt threatened or uneasy with the mention of Jimi's name, who accompanies us to memorials, dinners, trips to the mausoleum and listens to our remembrances we often share. He offers a shoulder to cry on, no questions asked and hugs when when there are no words to say. I have been blessed.

We find the inner strength to share our stories with those who unfortunately have & will walk in our shoes one day. Stand tall and proudly, know that our sacrifices and examples of selflessness have a ripple effect upon the lives of many. Our fallen heroes were not cowards and nor should we be. Live your lives to the fullest, remember that our loss does not define us, our successes and triumphs do.

Alameda County Sheriff Gregory J. Ahern is a big supporter of our club. In 2007 he founded a SWAT Team Training exercise, called Urban Shield, that has grown into one of the biggest and most respected in the Country. Teams from all over the nation come to train and compete in this event held the first week in September. In 2013 Sheriff Ahern expanded the training events to include Firefighters. The goal being to create the best training possible for police and firefighters.

This year over 500 peace officers and approximately 200 firefighters competed. Each team had to participate in competitions that included rescuing kidnapped victims, arresting terrorists, handling an airplane hijacking incident, and defusing bombs, to name a few of the over 60 different tactical situations.

In addition to the police and firefighter participants over 5000 volunteers helped set up the scenarios, manage them, and judge the different competitions. At the Trade Show our Club set up a booth and received almost \$10,000.00 in donations.


