CA and is a third-generation resident of Alameda County. Tom joined the Alameda County District Attorney's office in 1970, became the Chief Assistant District Attorney in 1989, and was elected District Attorney of Alameda County in 1994. He was reelected (without opposition) to three future terms as our District Attorney and served in that position until his retirement in 2009.

Tom joined The 100 Club in the early 1980s. During his time on the board, he has served on the Scholarship Committee as its chairman and has served two terms as our club President. Tom is currently serving as the immediate Past President of our board.

Tom says: "In my experience when a police officer or firefighter dies in the line of duty there is an initial outpouring of support from the community. Over time the tragedy seems to be forgotten. However, the 100 Club keeps the memory of our fallen heroes alive. The Club provides ongoing moral and financial support to the families to help them survive. I am proud to be a part of that effort."
