Several important things have happened in our family since our only son, John Raymond Hege, an Oakland Police Officer, EOW 3/22/2009, was killed along with three other officers after being shot on March 21, 2009. He was an organ donor and sadly his heart recipient died of Covid in early September after an additional 12 years of life. It was almost like losing John twice. John's heart recipient had not been

vaccinated because he was immune compromised because of the transplant. We had met him in past years at the golf tournament in John's honor.

The good news has been the marriage of our daughter Anne to someone who reconnected with her after John's death. They now have three daughters and live in Kensington, CA. Our older daughter lives in Hays, KS with her husband and both their sons will be at Kansas State next year. Sadly, John's father, Dr. John Steele Hege died of an ocular melanoma in January of 2017. Leaving my old neighborhood was hard but I'm appreciating my "home" at St. Paul's Towers in downtown Oakland.
